<b>Observation:</b> Staff did not follow the residency agreement and entered a resident's suite without the resident or responsible party's permission.						

**Actions taken or to be taken by Registrant (Operator):** The registrant must ensure that staff are trained and follow operational policies and procedures relating to residents' personal privacy.

The registrant must review with current staff and educate new staff the expectations regarding entering a residents' suite without the resident or responsible party's permission.

**Actions taken or to be taken by Registry:** No further action.
